- Qualifying times required. Current qualifiers listed on team website.
- **Sign-In Sheet** now posted on team bulletin board. **Entries due by Tuesday, February 16th at 8PM.**
 - Swimmers can choose their own individual events and the coaches will assign relays.
 - **Swimmers may enter up to three individual events.**
 - **Bonus Events-** If a swimmer only qualifies for one or two individual events they may also enter bonus events up to the maximum of three total individual events. In bonus events swimmers do not need to meet the minimum Q time, however they may not exceed the maximum Q time.
 - **Swimmers must circle the events they would like to swim on the sign-out sheet.**
 - **If events are not circled for a swimmer it will be assumed that they will not be attending the meet.**
- T-shirts must be pre-ordered at a cost of \$15.00 per shirt.
 - **To order shirt please write shirt size in designated spot on sign-out sheet** and put check in team deposit box under family folders for **\$15 made out to LCY Swim Team Parents Association.**
 - **Shirts will only be ordered if check is placed in deposit box by Sign-In deadline.**
