

# NWOWI 2010

**Eighteenth Annual Northwest Ohio Winter Invitational Swim Meet**  
**Sponsored by the Sylvania Tsunami Swim Club**  
**January 9 and 10, 2010**

**Bowling Green State University**  
**BGSU Student Recreation Center – Cooper Pool**  
**Bowling Green, Ohio**

**SANCTION:** This meet is sanctioned by USA Swimming and Ohio Swimming, Inc. Sanction #OH3217.

**ELIGIBILITY:** All age groups and ability levels. Swimmers **MUST** be **2010** registered members of USA Swimming.

## **GENERAL ORGANIZATION/SCHEDULE:**

**Saturday:** **10 & under, 11-12 Boys** - Warm-ups: 7:15-8:00 a.m.; meet will start at 8:15 a.m.  
**11-12 Girls, 13 & Over** - Warm-ups will last 45 minutes and will start immediately after the morning session, but no sooner than 11:00 a.m. Afternoon session will start 15 minutes after warm-ups conclude. Teams will be provided with tentative warm-up times the week prior to the meet.

**Sunday:** Same schedule as Saturday.

\*Host club may only accept the fastest 20 entry times for the 500 free and 400 IM.

**\*\*Host club reserves the right to limit the number of swimmers in any event due to time constraints and entry numbers.**

**All events will be conducted on a Timed Finals basis.**

**WARM-UPS:** Controlled, supervised warm-up sessions will be utilized in accordance with the warm-up procedure guidelines suggested by USA Swimming. A 45-minute warm-up period will be held prior to each session. The first 25 minutes will be limited to general warm up (circle) swimming. **NO DIVING** from blocks or pool edge will be permitted until the lane is declared a sprint lane by the Meet Referee. A coach must be present at the blocks of sprint lanes to supervise and/or start swimmers using the blocks. All coaches should position themselves at poolside to supervise warm ups.

**ATTENTION COACHES:** Only coaches displaying deck passes will be permitted on deck. USA Swimming badges also must be prominently displayed. Please inform parents of team members that the Security staff will not allow them on deck unless they are officials or non-athlete members of USA Swimming who display USA Swimming badges.

**FACILITIES:** The meet will be contested at Bowling Green State University Recreation Center Natatorium on the campus of the Bowling Green State University. The competition will be in a 10 lane x 25 yard pool that is 12 – 18 feet deep. A Colorado Automatic Timing and electronic scoreboard will be utilized as well. Lockers are available in the locker rooms though swimmers must provide their own lock.

**CONCESSIONS:** Food and university sponsored beverages will be available in the concession area. Everyone is encouraged to patronize the concession area. Heat sheets will be available in concessions area. No food will be permitted on deck except in designated areas.

## AWARDS & SCORING:

- Individual events -- First through third medals and ribbons for fourth through sixteenth.
- Relay events – First through third medals
- Open events will be scored and awarded 13 – 14 & Open.
- Heat winners will receive ribbons in the morning session excluding the 11-12 boys.
- Swimmers who are deck entered swim for time only and will not be eligible for awards or scoring points for deck entered events.

**FINAL RESULTS** Anyone who would like a copy may request one from the Entry Coordinator for a fee of \$5 in cash or by check to the Sylvania Tsunami Swim Club. Mail it to the address listed below. Coaches may get a TM or MM back-up once the meet is completed.

### Instructions for filling out entries

- This may be your first meet of 2010. **The swimmer's USA Swimming number MUST be valid for the year 2010!** Any swimmer that is not properly registered according to the LSC Registration Chairman will not swim.

***Please use TEAM MANAGER or MEET MANAGER by Hy-Tek, to submit your entries on disk or via e-mail. All entries must be accompanied by a complete printout that has been checked for accuracy.***

**RULES:** Current USA Swimming regulations shall apply. FINA whistle starts will be used for this meet. There will be no recall starting procedure for false starts. All athletes will be informed of a disqualification as a result of a false start at the completion of the heat. No swimmer may compete in more than 5 events per day, excluding relay events. Swimmers may compete in the age group corresponding to their age as of January 9, 2010.

Checks should be made payable to the SYLVANIA TSUNAMI SWIM CLUB. Entry deadline is **Friday, December 11, 2009**. Submission of entries on or before the deadline does not guarantee that the meet will still be open. All entry fees and forms should be returned to the Entry Chairman.
